Tips

Know How to Report Suspicious Activities

Just recently there have been reports of suspicious activities on our reserves. Here are a few tips on knowing what to report and how to report suspicious activities and individuals to ALIB Security and/or R.C.M.P. As a community member you can provide valuable information, however remember your job is to simply to report and ALIB Security or law enforcement will check out the situation.

What exactly is a suspicious activity? Suspicious activities can refer to incidents, events, individuals or circumstances that seem unusual or out of place. Some examples include:

A stranger loitering in your neighbourhood or a vehicle cruising the streets repeatedly, someone peering into cars or windows; a high volume of traffic going to and coming from a home on a daily basis, someone loitering around school, parks or secluded areas, sounds of breaking glass, gunshots, screaming or fighting.

A quick and accurate description of events, vehicles and persons can make all the difference in apprehending a potential criminal. By reporting these types of suspicious activities will help make our communities safer, more secure, and improve the overall quality of life.

When reporting suspicious activities, provide as much detail as possible. Start with the basics and get more specific. One reliable method to consistently make good suspect descriptions is to begin at the head and work your way down. Here is a list of items you can describe when providing a suspect description:

- Sex—male or female
- Race - white, black, aboriginal, asian or other
- Age
- Height and weight
- Hair colour and style
- Complexion—skin tone, imperfections
- Speech—accent, slurred, vulgar
- Scars—tattoos, facial hair, glasses
- General appearance—dirty, well-groomed
- Clothing—colour, style, shoes, jewelry

When reporting suspicious vehicles, provide as much information as possible about the vehicle, its occupants, the license plate or any identifying marks or characteristics, its activities and direction of travel. If you have a paper and pen handy, write down the information.

- Make—Ford, Chevrolet, Honda
- Model—Escort, Impala, Pick-up truck
- Year
- Colour
- License plate number and province
- Bumper stickers, damage or dents, lettering
- Direction of travel
- Occupants—example one male and one female about high school age

When reporting locations of suspicious activities, provide as much information as possible. An exact location and specific address is always best if possible. Or if not known, provide closest streets, highway or familiar landmarks.

Remember to always lock your doors, vehicles, know where your children are. Call ALIB Security or RCMP with description or details.
