Adams Lake Band Agrees to:

- K – 12 School Supplies \$50.00/student/year for **extra** school supplies, other than what schools provide
- K- 12 School Fees – **Paid directly to School** for (YPC, Band, School Supplies, Field trips, Grad Fees, Gym Strip) must be pre-approved by ALB Education prior.
- Extra-Curricular Activities funds is based on funding availability and **MUST** have **Pre-Approval** prior submission – include all supporting documents along with cost to ALB Education Dept. (Basketball, Volleyball, Band, etc.,)
- All non-mandatory extracurricular fees ALB will cover ½ cost (i.e.: registration fees, etc.) depending on grades & attendance
- Field trips, school supplies, fees, etc., **Under \$5.00** responsibility of parent/guardian
- Gr. 8-12 School Fees – **Paid directly to School** or by original receipt for current year - * Wood Work, Metal Work and Sewing, Art projects must be completed/passing grade prior to full payment is issued.
- Gr. 8-12 High School allowance (paid Dec & June) based on attendance and grades
- Graduation – **Paid directly to Parent** for Cost: pictures & Clothing, yearbook (set rate) based on funding availability – ALB Education receives Grad Picture.
- ALIB Education will assist with set rate per ALIB student (member) who reside off reserve per school (Sept to June) for school related costs based on funding availability

Parents' Consent to the Adams Lake Band for Accessing:

- 1) Monitoring your child's schooling for purposes of student success. Parents have the final responsibility for their children's education
- 2) Attendance records, progress and assessments
- 3) Publicize accomplishments and achievements
- 4) Provide high school allowance incentives upon receipt of report card; No adjustments, amendments or prepayments will be made after initial report card handed in. Absenteeism & Lost/Damage book fees will be deducted; excused absenteeism is for illness only and school approved activities
- 5) Parents are responsible for fees/cost: Lunch Hour Supervision, Textbook deposit, Transportation (Bus Pass), Room & Board, Lunches – Repayment of fees paid for field trips if your child (ren) do not attend & require pre-approval from ALB Education Dept.
 **Notify school to send school fees to ALB Education Department; give copy of K-12 Consent form to school
- 6) Non-mandatory school activity fees parents agree to pay ½ cost registration fees, other costs. subject to funding – parents
- 7) To access to files regarding social issues affecting education i.e.: referrals, case management for follow up purposes.
- 8) Agrees to camera monitoring on ALB bus for purpose of safety of students riding on ALB bus
- 9) Release information to ALB Education i.e.: Band #, etc. from other organizations, companies, agencies.
