### Terms and Conditions:

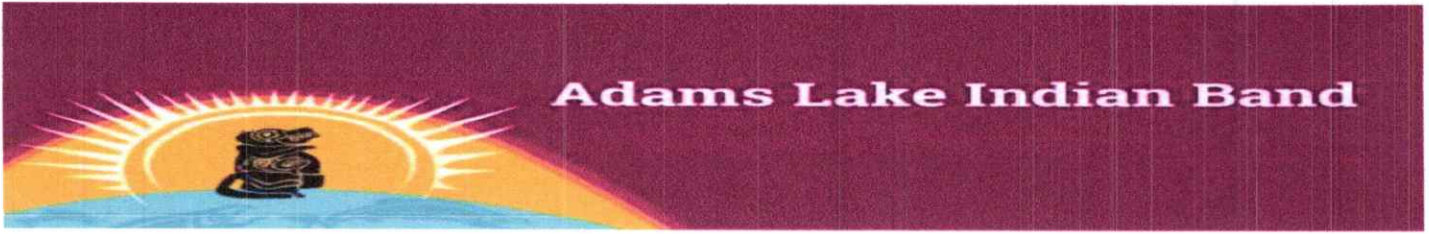
- Please develop a 2 minute (maximum) video clip of your talent.

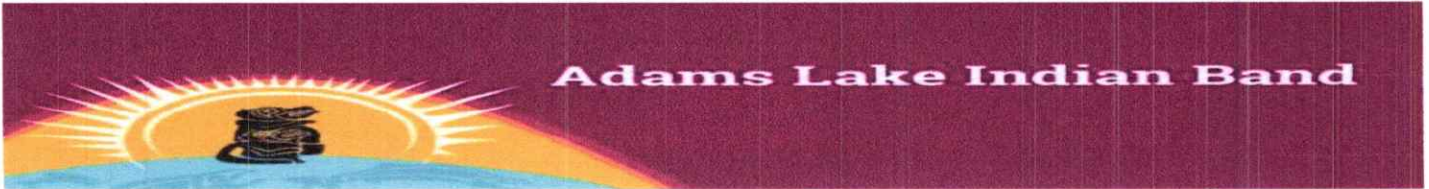
