Adams Lake Indian Band Council passed a Band Council Resolution BCR # 2018-2019: 356 on December 18, 2018 that encompasses people that are in arrears with the Adams Lake Indian Band, and working for the Band or its affiliates as a contractor/company or employee. Any cheques made to people with arrears will have a percentage of their wages/contract deducted automatically and across the board to go toward their arrears.

RESOLUTION OF THE COUNCIL OF THE ADAMS LAKE INDIAN BAND

(hereinafter, called the "Council")

WHEREAS the Chief and Council for the Adams Lake Indian Band was elected by the members of the Adams Lake Indian Band.

WHEREAS the Chief and Council for the Adams Lake Indian Band are empowered to make decisions on behalf of Adams Lake Indian Band

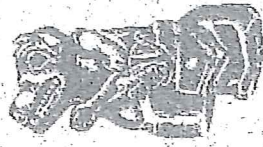
WHEREAS the Adams Lake Indian Band has members with arrears in such areas as housing, day care, social assistance, contract work etc.

WHEREAS the Adams Lake Indian Band does not currently have a policy of automatic payroll Deductions as a condition of employment nor for contract work

WHEREAS the Adams Lake Indian Band has trouble in the collection of arrears and limited ways Collect on delinquent accounts

THEREFORE BE IT RESOLVED The Adams Lake Indian Band approves of automatic payroll deduction for new employees with a minimum current rent which is set by the Housing Department, and 10% toward any arrears on top of the monthly rent. Further, members with arrears that successfully obtain contracts from the band must pay 15% of labour costs/profit for contracts with a contract minimum of \$500.00
